All children in KS1 participated in swimming lessons. All children gained an understanding of water safety.	89% of children in Year 2 achieved a greater distance when swimming than they did in year one. "This is the best day ever"- Year 1 child "I can swim 50 meters now"- Year 2 child "When I first went swimming I was scared but now I can jump in and be safe".
